U.S. STATE BALLOT MEASURES, 1902 – 2016

The following database of all U.S. state ballot measures attempted from 1902 – 2016 was compiled directly from the National Conference of State Legislatures' (NCSL) "Ballot Measures Database." The database includes all types of ballot measures (e.g., legislative referendum, initiative, popular referendum), type of election (e.g., general, primary, special), whether a measure passed or failed, the percentage yes votes for the measure, and the category of topic area (e.g., abortion, banking and finance, bond measure, business and commerce, civil and constitutional law, criminal, alcohol and drugs, education, gambling and lottery, health, human services, insurance, labor and employment, legislatures, local government, natural resources, state government, tax and revenue). Topic area categories were created by NCSL and each measure was categorized into one or more topic areas by NCSL.
